4. A list of final candidates for all positions will be published on October 02, 2017.
5. The final Voter List will be published on October 03, 2017.
6. Elections are to be held on October 08, 2017 during Dashain Tihar Mela – Election date is unchanged.
7. Election Results will be announced on the same day
